

## **THE MIA MEMORIES SWEEPSTAKES OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN.

A PURCHASE WILL NOT IMPROVE CHANCES OF WINNING. VOID WHERE PROHIBITED.

**ELIGIBILITY:** The Miami International Airport "MIA Memories" Sweepstakes (the "Sweepstakes") is open to legal residents of the fifty (50) United States of America and District of Columbia who are eighteen (18) years of age or older at the time of entry. Limit one (1) Entry per person. Odds of winning depend on the total number of eligible Entries received. Limit one (1) prize per person, family or household. Miami-Dade County's determinations of all matters related to this sweepstakes shall be final and binding.
