TITLE: Miami International Airport (MIA) Central Terminal Ticket Counters, Conveyors, and K-1 doors for TC 12 through TC 17

This Addendum becomes a part of the subject solicitation.

A. The following are changes to the Bid document.

- a. All references to the bid submittal due date shall now mean Wednesday, November 30, 2022 at 2:00 pm EST.
- b. The following has been deleted in its entirety. Standard Construction General Contract Conditions, 12. Miscellaneous Provisions, Item Q, User Access Program (UAP)
 - Q. User Access Program (UAP) Not Applicable Pursuant to Miami-Dade County Code Section 2-8.10. User Access Program in County Purchases this Contract is subject to a user access fee under the County's User Access Program (UAP) in the amount of two percent (2%). All construction services provided under this contract are subject to the two percent (2%) UAP. This fee applies to all Contract usage whether by County Departments or by any other governmental, quasi-governmental or not-for-profit entity. From every payment made to the Contractor under this contract (including the payment of retainage), the County will deduct the two percent (2%) UAP fee provided in the ordinance and the Contractor will accept such reduced amount as full compensation for any and all deliverables under the contract. The County shall retain the two percent (2%) UAP for use by the County to help defray the cost of its procurement program. Contractor participation in this pay request reduction portion of the UAP is mandatory.
- c. All references to Art in Public Places are hereby deleted and will not be applicable to the subject agreement.
- d. MDAD-CIP-V043A-4 Volume I of II, Schedule of Prices Bid, item a shall now read...
 - a. The total bid amount shall include all items needed to provide a complete, operable and maintainable system for MDAD to use as intended, to include, but without limitation; all equipment, labor, material, tools, supplies, supervision, incidentals, engineering, design, manufacture, delivery, construction administration, project management, installation, testing,

- startup, commissioning, permitting and any other item necessary to fully complete the work pursuant to this solicitation.
- e. MDAD-CIP-V043A-4 Bid Set Specs Volume II of II, 34 77 16 Baggage Handling Equipment, 4. Quality Control, 4.2 Inspection/Testing and Acceptance, B. Conditional Acceptance Operational Period, items a. and b. are replaced in their entirety as detailed below...
 - 8. Conditional Acceptance Operational Period
 - a. Upon issue of a Certificate of Conditional Acceptance for the final, a 30 day Operational Period per POD (consisting of two ticket counters) will commence in which MDAD will put all systems into on-line operations processing the daily flow of baggage.
 - b. From the start of the Operational Period, provide full-time technical site representation for 7 days during the actual hours of operation with a minimum of 16 hours per day per POD. Ensure that the representatives shall be capable and duly qualified personnel per shift to trouble shoot and immediately resolve any problems, which may arise. The BHS Subcontractor's on site personnel shall be capable of troubleshooting and resolving all electrical and controls related issues.
